2 Assistant Professor positions with tenure in Economics, University Paris Dauphine – PSL, Paris, France

The Department of Economics of Université Paris Dauphine – PSL invites applications to fill up 2 permanent tenured positions at the Assistant Professor level (Maître de Conférences) beginning in September 2022.

For the first position, applications are invited in all fields of Economics.

For the second position, we are looking for candidates specialized in time series econometrics / financial econometrics. The recruited person is expected to teach at Bachelor's and Master's level and to carry out active research on one or both themes.

The annual salary is 25,000 - 40,000 Euros after taxes, depending on experience and qualification. We also offer a light teaching load during the first three years (approximately 75 hours/year). Knowledge of French is an asset, though not required.

In view of this recruitment process, the Department of Economics organizes “**Days at Dauphine**” to take place between **April 6 and April 8, 2022**. Candidates to the Assistant Professor positions are encouraged to participate in these “Days at Dauphine”.

During this event, the candidate will have the opportunity to present her research work (plenary session), as well as to discuss with the members of the Department of Economics more informally during bilateral meetings. If the sanitary conditions allow for it, the event will be organized on site. Yet, on-line sessions can be organized for foreign candidates upon demand.

Instructions for the application to the Days at Dauphine

Candidates must have completed a Ph.D. in Economics by January 17th 2022.
